Paired as close to weight as possible. 3rd - 8th competitive scoring 4 man round robin. Overtime matches will be decided by sudden death.

Weigh Ins: - No weigh ins! Send in correct weight of wrestler on entry form done by club coach. We will weigh any wrestler that is questionable and Disqualification will result if found 3 lbs. over entered weight. Coaches, please stress this to your wrestler and parents.
