3 man round robins wherever needed.*
- ENTRY FEE:** *Pre registrations: \$10.00 per wrestler received by March 28TH (SORRY NO REFUNDS)  
Late registrations: \$15.00 per wrestler. Entries will be accepted at the door or by telephone.*
- AWARDS:** *EVERYONE MEDALS. Large 1<sup>st</sup> place medals for 3<sup>rd</sup> through 8<sup>th</sup> grades.  
There will also be a FAST PIN TROPHY awarded in each age group(3<sup>rd</sup>-4<sup>th</sup>, 5<sup>th</sup>-6<sup>th</sup>, 7<sup>th</sup>-8<sup>th</sup>)*
- SCORING:** *Three one minute periods Pre K through 6<sup>th</sup> grades. All periods begin in neutral position. No scoring Pre-K though 2<sup>nd</sup> grade. 7<sup>th</sup> and 8<sup>th</sup> graders: Three 1 ½ minute periods wrestlers choice of positions in second and third periods. All Huskerland rules apply.*
